

Orthodontic Case Giveaway Rules and Conditions

DENTAL OFFICE: Element Dental & Orthodontics – Bryan

1. NO PURCHASE NECESSARY TO NOMINATE or BE NOMINATED. A purchase will not increase your odds of being chosen. All federal, state, local and municipal laws and regulations apply. Void where prohibited.

2. No Substitutes of Orthodontic Case. The "Orthodontic Case" of a "\$5,400 (approximate retail value per recipient) Orthodontic Case" cannot be substituted for cash value equivalency nor any other substitute value other than what is specifically defined as the "Orthodontic Case" within these rules.

3. Eligibility. The Orthodontic Case Giveaway is open to individuals 21 years or older at the time of nomination and is only open to legal residents of Texas. This Giveaway is void where prohibited. In order to be eligible for nomination, the nominee must live within a 50 mile radius of DENTAL OFFICE. Employees of DENTAL OFFICE, the immediate family members thereof, and any persons domiciled with such employees, are not eligible.

4. Nomination. Nominations will be accepted beginning at 12:01 a.m. (E.S.T.) on October 23rd, 2017 and all nominations must be received by 11:59 p.m. (E.S.T.) on November 10th, 2017. Individuals may nominate themselves or another nominee via the Official Nomination Form. Each individual can nominate themselves only once. However, with the permission of the individual being nominated, someone may submit a nomination on their behalf to increase their odds (the nominee) of becoming a finalist. If the nominee is being submitted by anyone except himself or herself, all of the nominee's info must be correct in order to confirm the nominee's identity. In addition, whoever is entering the information on behalf of the nominee must also leave their info so we can verify their identity as well. - Internet Nomination: Enter by visiting the official registration page on the Orthodontic Case Giveaway webpage on <http://myelementdental.com/locations/bryan-tx-office/> and access the Official Nomination Form. Complete the Official Nomination form by following the instructions on the website. Your computer must accept cookies, or any successor or similar technology, which may be used for the purpose of nomination tracking. By entering, you agree to the terms of these Official Rules and to receive e-mails from DENTAL OFFICE. You can opt-out of the receipt of such e-mails by following the directions in any email received from DENTAL OFFICE.
- DENTAL OFFICE will not be responsible for incomplete, lost, late, "post due," misdirected or illegible nominations or for failure to receive entries for any reason, including but not limited to transmission or technical failures or malfunctioning of any telephone connection, network, hardware or software. All entries become the property of DENTAL OFFICE and no portion of the nomination will be returned.

5. Giveaway and Odds. One chosen nominee will receive an "Orthodontic Case Giveaway package" (approximate retail value of \$5,400) and will be selected by a committee formed by DENTAL OFFICE from among the finalist nominees chosen. 6. General Dentistry Clearance. All final nominees will be required to complete a general dentistry evaluation at DENTAL OFFICE at no cost. Only patients who are cleared by a general dentist to move forward with orthodontic evaluation and treatment will be eligible to be selected for the giveaway.

7. Orthodontic Case Recipient Notification and Acceptance. Finalists will be notified by phone and email between 10/23/2017 – 11/10/2017. If a finalist or potential recipient does not respond to our notification and/ or is unable to complete the comprehensive oral exam at the office of DENTAL OFFICE within the period of 10/23/2017 – 11/10/2017, such potential recipient will be disqualified. Final recipient will be announced the week of 11/20/2017. DENTAL OFFICE reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this Giveaway as solely determined by DENTAL OFFICE. In the event the Giveaway is compromised by a virus, non-authorized human intervention, tampering or other causes beyond the reasonable control of DENTAL OFFICE which corrupts or impairs the administration, security, fairness or proper operation of the Giveaway, DENTAL OFFICE reserves the right in its sole discretion to suspend, modify or terminate the Giveaway.
